

**Pikeland Community School  
Administrative Report  
Oct. 18, 2017**

- Over the past couple of weeks, I have met with my grade-level teams to review assessment data and set goals for math facts and reading fluency.
- On the October 5 Teacher Institute Day, staff attended the Quincy Conference, Google training, or worked on IEP's.
- On October 12, in cooperation with the Pittsfield Fire Dept., we conducted a fire drill. Though there are always areas we can improve, staff and students responded very well.
- October 21 – Student council will hold a Halloween party for all third through fifth grade students. Students will watch a movie, play games, and tour the haunted hallway.
- October 25 – We will be holding a safety drill at Pikeland Community School. The drill will be held in cooperation with our local law enforcement authorities. This will be a live fire drill, which means authorities will fire off blanks to simulate gunfire to begin the drill. Additionally, students will be evacuated to our off-site location. This drill allows us to practice our safety procedures and is critical to our preparation.
- October is "National Bully Prevention and Awareness Month". In an effort to bring awareness to this issue, our PBIS efforts are focusing on bullying this month. The PBIS mini lessons we teach will be related to bullying. Students will also participate in a Bullying presentation. In addition, PCS students and staff will be wearing black on Friday's for the rest of October. Feel free to join us as we blackout bullying.
- Columbus Day weekend, eighteen eighth graders went on the Washington Trip with Ms. Foster and Mrs. Frieden. Students left school at 2:00 A.M. on Friday, October 6. This was the beginning of a fast and furious three days of memorial viewing and historic sightseeing.
- October 17 - Last night, approximately twenty students enjoyed activities at the D pod Family Fun Night. During this activity, students played basketball, ping pong, volleyball, and played board games.
- The first quarter will end Friday, October 20 and grades will be mailed home Friday, October 27.
- The junior high baseball team won a sectional title and competed in the state tournament. It has been twenty-one years since we won our last sectional title.

- We are wrapping up the first quarter on Friday. Report cards will go home October 27th.
